



## SWELL 171 • BEGINNING SWIMMING

**COURSE CONTENT:** Beginning techniques of swimming, basic swimming skills and standard swimming strokes. Form and technique in freestyle, backstroke, breaststroke, front and back float, treading water, continuous kick, underwater swimming, flip turns, surface dives, and open turns.

### LEARNING OUTCOMES

1. Students will be able to perform proper form and technique in the standard swimming strokes (freestyle, backstroke, and breaststroke).
2. Students will be able to perform at a beginning swimming fitness level (500-yard swim).
3. Students will be able to explain the techniques and principles of swimming.
4. Students will value and be able to apply general principles of fitness and well-being that will encourage lifelong wellness and assist in the active pursuit of their best selves.

**CLASS ATTIRE:** Student Wellness supports the BYU Honor Code, including the Dress & Grooming Standards. Appropriate workout attire for all SWELL classes includes tops that cover the shoulders, stomach, and back; mid-thigh shorts or longer (no exceptions); and no cut-off shirts, jeans, boots, or open-toed shoes. Exercise leggings are permitted. Inappropriate logos or sayings will not be tolerated. ***Students not dressed appropriately will not be allowed to participate and will be marked absent.*** Water activity attire is as follows:

- Swim attire must cover appropriate body parts and be worn correctly. Women's suits must cover the midriff.
- All swim attire must be specifically made for swimming pool usage. Prohibited attire includes, but is not limited to: Athletic wear not made for swimming, compression shorts, leggings, basketball shorts, jeans, cotton clothing, & undergarments.
- Lifeguards may ask those not in compliance with this policy to change or cover-up prior to utilizing RB Pool Facility.
